### VE Test Session

On 12 July 2024, there will be a VE Testing Session at the Northampton County 911 Center at 7pm. Candidates are required to pre-register. You must contact Bob Green, KE3AW by phone 610-419-9286 or email address <u>ke3aw@arrl.net</u>. Bob will inform the candidate on what is required and prohibited, etc, the date, time, location, verification required, directions, etc. The candidates need to know they should get their FRN number prior to the testing. If they do not have that FRN number (SS number cannot be used), it will slow their paperwork flow and delay the license delivery to them. They also need to know the fee set by ARRL for their part in the checking process before their paperwork is sent to FCC in Gettysburg, and if paying by check, it shall not be made to any member of our VE Team nor to DLARC. And finally, the \$35 the feds are charging for their 10-year license.

Also, there are classes in the Spring and Fall, 10 sessions, the 10<sup>th</sup> being the VE session. If there is a need by the County to use the 911 Center on any of the Tuesdays we scheduled for classes, the VE gets pushed to the next Tuesday that still would be the 10<sup>th</sup> session.

Location is set for 911, 7:00 p.m. on odd number months, on the first Friday after the first Thursday (DLARC Meeting date). Since the Club meeting is on the second Thursday of July because the 4<sup>th</sup> was on the previous Thursday. So, as usual the VE session will be on the Friday, July12th after the meeting no matter.

Just a reminder that there will also be a VE Test Session at Field Day on Saturday the 22<sup>nd</sup>. Need to follow the procedures to make sure you are listed to take the test you wanted.

# ARRL AND RENEWALS

Since there are a few new members to the Club, I thought it would be idea to say something about ARRL. There have been some changes this year, there is still a lot of talk. ARRL gives back to Amateur Radio. You can check out the ARRL website and see a lot more on what this hobby is all about.

As you know, the ARRL has raised their membership dues starting 1 January 2024.

All ARRL members need to check their QST mailing slip to see when their membership expires. Now members have to decide on what they want to do.

The dues went up \$10, from \$49 to \$59. The biggest change is that if you want to continue getting QST or On the Air magazines in the printed form, it will cost you \$25 per magazine. If you are willing to get those magazines in digital form, there are no extra cost

You have a choice in how many years you want your membership. One year is \$59 and 3 years is \$175. You still have to pay \$25 a year for the printed form of the magazines.

The Club benefits from ARRL membership by getting a commission on new members and members that renew. It is not much, but every little bit, it helps the Club. In order to be an Affiliated Club, you need to have at least 51% of the voting members be either Full or Associated members in the Club. At least 51% of the voting members must be licensed radio operators.

All repeaters on the net are linked through **Reflector 020 port A**, so all stations checking into the net should make sure that they have *their local repeater call sign followed by the letter "G" in the eight positions of the RPT2 field*. Otherwise, you will only be heard locally and not over the Reflector. Dongle users wishing to check into the net should Log On by connecting directly to Reflector 20, port A, rather than through your local repeater to conserve local bandwidth.
