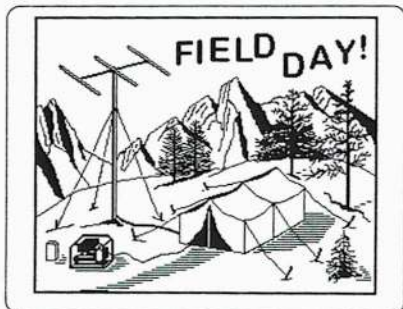

## Another Mayday story

It was not quite a dark and stormy night on Monday, April 7, but I was sitting in the shack reading an article on the internet while waiting for the Pacific Seafarer's net to start on 14313.

Out of the darkness, I heard a woman's voice call "MAYDAY, MAYDAY this is the sailing vessel 'Ragtime', KF6PXF, off the coast of Honduras, calling MAYDAY".

I listened for a second to see if anyone would respond. When no one did, I got on frequency, identified myself as a radio operator with the United States Coast Guard, and got the "4 P's" Coast Guard operators are taught to get (How many "POB'S" (persons on board), what the problem was, position, and told her to put on her PFD (life jacket)).

She said she and her husband had run aground a few miles outside of Honduran territorial waters. They weren't taking on water, had no injuries, but the weather was deteriorating, and they were concerned. I contacted "CAMSLANT", the Coast Guard Rescue Coordination Center for the eastern US. They patched me through to USCG Station Miami. I identified myself as both a ham and Coast Guard radio operator. Station Miami has no HF capability, and they weren't quite sure how to work this, so I put them on phone patch with the distressed vessel to get more info.

Once they got that, they said they'd call me back with details on how they'd handle the situation. To ensure their safety, I maintained a communications schedule with the "Ragtime" every 20 minutes. Miami called me back about 30 minutes later. The USCG Cutter "Mohawk" was about 50 miles from "Ragtime", and was being sent to assist. "Mohawk" came on frequency about 30 minutes later, so I gave them the particulars, and turned over the radio guard to the Cutter.

The next day I got a call from the brother of the captain of the "Ragtime". He said the Coast Guard got the vessel off the reef, and everyone was safe. He said he, and the crew of the Ragtime were grateful to have the help of ham radio operators.

Together, the American Red Cross and the club can save a life. Thank you for your time and your consideration in this subject matter.

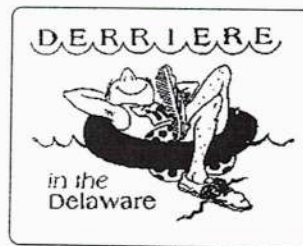

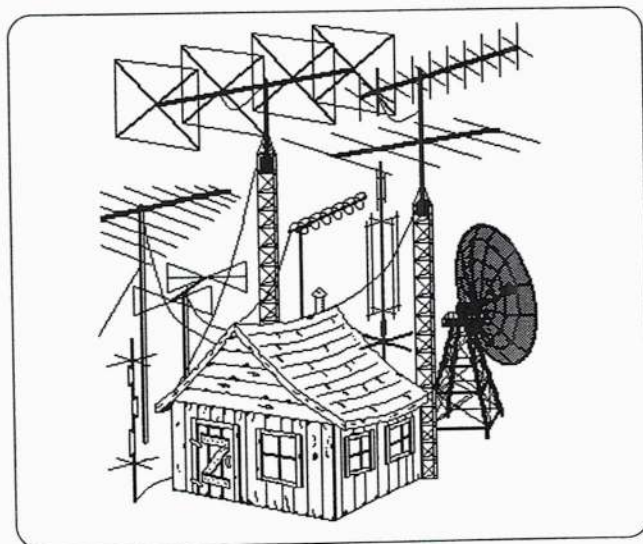
One former CB who graduated to amateur radio , used to operate a low power fm broadcast

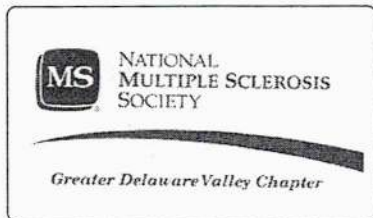

## FCC affirms hefty fine for amateur in interference case

The FCC has affirmed a \$12,000 fine against Technician-class Amateur Radio operator Scott E. Kamm, N0UGN. The FCC released a Forfeiture Order May 7 alleging willful and repeated interference, broadcasting of music and failing to identify with his call sign. The FCC's Kansas City office had released a Notice of Apparent Liability for Forfeiture (NAL) on January 24, but Kamm never filed a response, the FCC said. The Commission ordered Kamm to pay the fine within 30 days.

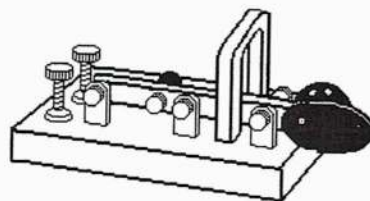
Kamm's station was in Waterbury, Nebraska, at the time he was cited last fall, although the FCC granted his February 27, 2002, application to change his mailing address to a location in Sioux City, Iowa.

Responding to complaints of continuing interference on the input of a 2-meter repeater, FCC agents monitored the machine's input frequency last December 9. They observed a very strong signal on 146.31 MHz "consisting of music, sound effects and unmodulated carriers" and no station ID. The FCC said the transmissions were interfering with amateur communications already in progress.

The FCC twice tracked similar signals to Kamm's residence in Waterbury, Nebraska, inspected his station and found a transceiver capable of operating on 146.31 MHz, the FCC said. Kamm claimed no transmissions were made from his station.

During 2002, Kamm was the target of several letters and an FCC Warning Notice from Special Counsel Riley Hollingsworth. Last fall, the FCC's Wireless Telecommunications Bureau set aside Kamm's amateur license renewal based upon complaints about the operation of his station and questions regarding his qualifications to be a licensee. Kamm's amateur license expired last September 29, and his license renewal application, filed August 8, has reverted to pending status.

## Contester's Rate Sheet

The boys and girls at Elecraft have been very busy getting ready for the Dayton Hamvention.

At Visalia, Eric WA6HHQ was showing off several new products:- The KDSP2 internal module kit for the K2 includes several CW & SSB filters, some user-configurable, and four different noise-reduction settings.- Thinking about VHF contesting? Try three new high-performance transverter kits for 6, 2, and 1-1/4 meters with 20-25 watts of output, sequenced amplifier keying, and front-panel wattmeters. Although they don't require a K2 host, integration with the K2 enables daisy-chained, automatic band selection and frequency display.- The new KRC2 is an automatic band decoder for external antennas and Band Pass Filter selection that works with all major radio serial interfaces, as well as with the K2. It features numerous switching configuration options, upgradable software, and a hefty drive capability.

The RS-232 configuration and control interface is a nice feature that makes it easy to set up complex switching functions. If you haven't taken a look at the K2 and K1 family of products lately, it will be worth your while to check out how Elecraft has grown -- <http://www.elecraft.com>.

MiLog 6.0 (<http://www.HamToys.com>) is both a general and contest logging program that is specifically designed for multi-radio and multi-rotator contest stations. I saw a demo at the Visalia DX Convention of its native support for Ethernet interfaces to antenna switching and control accessories such as the Shack-LAN radio and switching interfaces. With the Ethernet and TCP/IP support, no longer does everything have to be in reach of an RS-232 or parallel port cable. In fact, a multi-op team could have members literally anywhere with an Internet connection. MiLog handles DX cluster connections via TELNET or RF links, RTTY contest capability with an MMTTY module, and Cabrillo conversion of contest logs. It also has a superb built-in voice keyer. (Thanks, John N7ON)

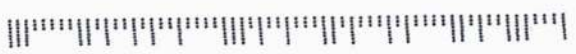
