#### **MINUTES FROM THE AUGUST 2013 MEETING**



A general membership meeting of the Delaware-Lehigh Amateur Radio Club Inc. (the Club) was held on August 1, 2013, at the Bethlehem Township Community Center located in Bethlehem Township, Pennsylvania.

**Call to Order:** Charlie Lazarchak / W3OPA, President, called the meeting to order at 1934 hrs. **Pledge of Allegiance:** Led by Charlie / W3OPA

What Have You Been up to Lately: Charlie / W3OPA opened the floor to members who wished to share any recent personal ham radio related activities, projects, or events:

George / N3SQD purchased a USB SDR radio at the Sussex Hamfest for around \$20. The unit receives from around 22MHz to just above 1 GHz. With SDR software, about 2 MHz of spectrum can be seen. An up-converter can be used to receive HF.

Paul / N0KIA renewed his license online. He was delighted with the ease of renewing online. Bill / K3ANS recalled that in the 50's the license renewal required an FCC field inspection of your shack and review of your logbook before you could renew your license.

John / W3OAB from Rochester NY has set up a temporary shack in Catasauqua. He has set up an NVIS antenna for 80 meters to contact friends back in Rochester. Unfortunately there is a steady 20 over S9 noise. The noise makes 75 meters is totally unusable. The noise diminishes up in frequency, but it can be heard almost up to 20 meters. Ben / KB3CTX will offer assistance in tracking down the source of the noise.

- Approval of the Minutes: Charlie / W3OPA asked for a motion to approve the minutes of the last meeting. It was moved by Dave / K3IWC, second by Mark / W2MB to approve the minutes as presented. Motion carried.
- Approval of the Treasurer's Report: Mike / KB3LOD presented the Treasurer's Report. It was moved by Jay / N3OW, second by Ed / AA3OU to approve the Treasurer's Report as presented. Motion carried.
- Club Station Report: Charlie / W3OPA reported that Barry / N3NVA will become the trustee for the DLARC club callsign, W3OK and that Jon / NJ3I will become the trustee for the Christmas City Club callsign, WX3MAS. George / N3SQD encouraged everyone to come out to the club station on a Wednesday night. Although nothing has been formally setup, Charlie / W3OPA encouraged members without an HF station at home to come out to the club station to participate in the PA QSO Party.
- **Repeater Report:** Charlie / W3OPA asked there were any recent problems or issues with repeater. No issues were reported by any of the members present.
- Website Report: Brad / W3JXQ reported the site was up and running. Charlie / W3OPA asked Brad to confirm that there were directions to the club station on the site.
- Newsletter: Don / KC3II reported no issues with the newsletter. Pete/NL7XM could not locate any information on a club newsletter competition; Bill / K3ANS suggested contacting the ARRL Club coordinator, Norm / W3IZ.
- Club Picnic: George / N3SQD reported that the Club Picnic is scheduled for August 25 (the last Sunday in August) at Louise Moore Park Pavilion No. 5. Al / W3CE will not be available to chair the club picnic this year. If anyone is interested in chairing this event, Al will be available to mentor you on what is involved in organizing the picnic.
- Visitors/Guests Present: John / W3OAB. John grew up in the Lehigh Valley and moved to Rochester, NY about 30 years ago.
- Membership Report: George / N3SQD reported that there was one application for membership. Henry G. Niemira (not licensed and not an ARRL member). It was moved by Pete / NL7XM, second by Doreen / K3PDL to accept the candidate as presented. Motion carried.
- VE Test Session: George / N3SQD reported there was a VE session scheduled for July 12 at the County 911 Center. The next scheduled VE test session will be in September on the Friday after the club meeting.
- Nominating Committee: Bill / NC3P reported on the slate for the upcoming election. The current slate is President: Jay / N3OW, Vice President: Dave / N3EYT, Secretary: John / NT3P, Treasurer: Mike / KB3LOD, Directors: Dave / KA3IWC, Doreen / K3PDL, Evelyn / W3DOY, Larry / KC3ANC, Steve / KB3WYJ, Rob / AB3RC, and Fran / KB3YTG.

- Program Chair: Charlie reported the Program Chair for next year is still vacant and that the Club needs this position filled so that planning can begin for presentations in 2014. Jay / N3OW added there will not be last minute scrambling for a program each month. Charlie pointed out that October is taken for elections and awards presentations and December is the holiday party. Barry / K3UX added that he and Ben K B3CTX are working on a program so a quarter of the programs are already potentially filled. Charlie mentioned that a group of members could co-chair this position to spread the workload.
- Circulation Chair: Charlie / W3OPA reported a Circulation Chair will be needed for next year. The duties primarily are to perform the bulk e-mailing of the Club newsletter each month. If you are interested, please see Charlie or Pete / NL7XM.
- **Board Meeting:** Charlie / W3OPA invited anyone who is interested in running for a Club Officer or Director to come to a Board meeting to see what goes on. The next meeting is 7 PM on August 22 at the 911 Center. If you do come to a Board meeting, please be aware that the invitation is as a guest to *observe* the business proceedings of the Board.
- Licensing Classes: Bob / KE3AW reported both Technician and General classes will be held starting September 10 at the 911 Center. Each course will be on Tuesday night for nine weeks. There will be announcements on the Club website, in local newspapers and on Service Electric Community Bulletin Board. If you know if anyone who may be interested in becoming licensed or in upgrading to General, let them know about the classes.
- **Upcoming Public Service Events:** Bob / KE3AW advised that the Emmaus Halloween Parade is on October 19. Bob explained that 15 to 16 operators are needed for the event. The operators are interspersed (in their vehicles) with the marchers so that any issues can be immediately reported to the parade organizer. The Club has been providing communications for this event for about 20 years. The parade organizers so depend on the communications provided by the Club that they rescheduled the parade one year when the original date conflicted with Pa QSO Party. Please see Bob if you are interested in the event.

Don / KC3II said he will have information about the Lehigh Wheelman's Gap Gallop and the other public service events in the newsletter. Don briefly went over the route which starts at DeSales University in Center Valley. Ben / KB3CTX added that although the name was changed back to the Gap Gallop, the route is a new one that will involve at least one area with limited repeater coverage.

Ben / KB3CTX reported the Black Bear Century bike ride will be on October 12, which unfortunately will be the same weekend as the PA QSO Party. There is no repeater coverage in the area; in the prior years 12-15 operators were needed for simplex operations. If it doesn't look like we can field enough operators, Ben will check other radio clubs for assistance.

Estate/Downsizing/Moving Sales of Ham Radio Equipment: Bob / KE3AW reported that several family members of recently passed hams have contacted the Club. They are interested in selling ham radio equipment from the estate, but are not familiar with the hobby nor know anything about ham radio equipment. Bob will work with sellers wanting to list ham radio equipment and will make the lists available for anyone who is potentially interested in purchasing equipment.

Bill / K3ANS reported that Skip / K3CC, a former long-time club member, and his wife may be moving back into the area. Bill said that Skip has been slowly reducing the size of his ham equipment collection so you may want to contact Skip to see if he has equipment for sale as part of a downsizing or moving sale.

Membership Cards and Club Badges: George / N3SQD reported that he has membership cards and badges from over 35 members. If you haven't received your club badge or 2013 membership card, please see George.

Call for Newsletter Articles: Don / KC3II said the newsletter can always use articles from members. If you are willing to contribute to the newsletter by writing an article, please feel free to contact Don.

#### AUGUST PROGRAM REPORT

#### **GPS Systems and Applications Simplified**

Ben / KB3CTX presented the program on Global Positioning System (GPS), and how it is a U.S.-owned utility that provides users with positioning, navigation, and timing (PNT) services. This system consists of three segments: the space segment, the control segment, and the user segment. The U.S. Air Force develops, maintains, and operates the space and control segments.

The space segment consists of a nominal constellation of 24 operating satellites that transmit one-way signals that give the current GPS satellite positioning and time

The GPS control segment consists of a global network of ground facilities that track the GPS satellites, monitor their transmissions, perform analyses, and send commands and data to the constellation.

The current operational control segment includes a master control station, an alternate master control station, 12 command and control antennas, and 16 monitoring sites.

The user segment consists of the GPS receiver equipment that uses the signals from GPS satellites and is used to transmitted information to calculate the users three-dimensional position in time.

A brief background on the history and development of the system and the future plans for expansion and improvement With slides, Ben demonstrated how the satellites were positioned and their orbital paths covered the earth. Showing just how information was gathered from more than one satellite to accurately locate your position.

Following the presentation there was an open question and answer period, which also included additional information from the audience

#### UPDATE AND CORRECTION

At the August meeting I mentioned that the satellite control facility, known as the CSOC (Consolidated Space Operations Center), was located at Falcon Air Force Station, about fifteen miles east of Colorado Springs. In the years since I toured the facility, it has been expanded, upgraded and renamed. It is now called Schriever Air Force Base and it is easy to find with Google maps. Just locate Colorado Springs, CO and spot Peterson AFB on the east side of the city. Now look eight miles east and you'll spot a roughly rectangular developed area in the middle of the plains. That's it!



#### LEHIGH WHEELMEN 2013 GAP GALLUP

September 15th is The Gap Gallup. Great scenery, varied terrain and lightly traveled roads make it one of the most enjoyable rides in the Northeast. After nearly 40 years, the Lehigh Wheelmen decided to make a change and introduce a new start location and an exciting new route for the traditional Gap Gallop. This year's route will start at DeSales University in Center Valley, PA. This scenic and challenging bicycle century will take you from the heart of the Lehigh Valley to the shores of the Delaware River where we will cross into New Jersey. Following the river north, the ride will pass through Phillipsburg, NJ to the first of 5 rests stops all stocked with great food and beverages to keep you fueled. After the first rest stop just north of Phillipsburg, the route will climb out of the river valley to a height of land with fantastic views of the valley below. Our second rest stop is in Belvidere, NJ. On the way you'll have the option to challenge your heart, lungs and legs with a climb of the famous, or infamous, Fiddler's Elbow. We'll be waiting at the top with a token to remember your achievement. Leaving Belvidere, the route continues north to Columbia, NJ then crosses the pedestrian bridge over the Delaware River to Portland, PA. It is on this bridge that you will be treated to one of the best views of the Delaware Water Gap, the geological formation for which the event is named. The third rest stop is at Driftstone Campground just south of Portland. From here it is a delightful ride in the river valley with great views along the way as we head south before crossing the river once more at Belvidere. The forth rest stop is the one you visited earlier on the way north. A different route from the one used on the way north takes you back to Phillipsburg, where you'll have the final rest stop where you had the first one so many miles ago. Then we cross the Delaware one more time and head up the Lehigh River for the last leg of the century. Al / W3CE is looking for operators to man the SAG wagons and the various check points. W3OK -145.11000MHz -0.600 Port C – W3OI -147.16500MHz +0.600 Port C, – W3OI - 445.02500MHz -5.000 Port B All repeaters on the net are linked through Reflector 020 port A, so all stations checking into the net should make sure that they have their local repeater call sign followed by the letter "G" in the eight position of the RPT2 field. Otherwise, you will only be heard locally and not over the Reflector. Dongle users wishing to check into the net should Log On by connecting directly to Reflector 20, port A, rather than through your local repeater in order to conserve local bandwidth.
