Rich gets an alert each time someone wants to gain access to our website. Even if they manage to create a log in and password, no one can do anything on the website unless Rich elevates them to active status. They are classified as a registered user but they must FIRST be recorded as a member of the club to gain access to all aspects to the website.

Bill Goodman, K3ANS, mentioned that some people want to know how to connect to the DLARC reflector. That information should be added to the website.

Mark Bond, K2MB, asked if it would be expensive to give our website a more modern look. Rich explained that he is more a web administrator than webmaster, and that he does not have that capability. ARRL FOUNDATION INVITES SCHOLARSHIP APPLICATIONS FOR 2019-2020 ACADEMIC YEAR

The ARRL Foundation will begin accepting scholarship applications_onOctober 1 from eligible radio amateurs planning to pursue post-secondary education in the 2019-2020 academic year. Completed applications must be received by January 31, 2019. Individuals and clubs support many of the more than 80 scholarships, ranging from \$500 to \$5,000, that are awarded annually. Applicants for all scholarships must be active radio amateurs and must complete and submit the online application.

"The ARRL Foundation Board of Directors is honored to be able to continue to offer scholarships to assist Amateur Radio operators in offsetting the costs of higher education," said ARRL Foundation Secretary and ARRL Development Manager Lauren Clarke, KB1YDD. "All ARRL Foundation scholarships are made possible by individuals or clubs, and we are grateful for their support."

Students planning to apply for 2019-2020 academic year awards should first carefully review the eligibility requirements and scholarship descriptions. Although only one application per applicant is required, applicants may ask to be considered for as many of the scholarships for which they are eligible (some scholarships have geographic criteria or other requirements). Check off only the scholarships for which you would like to be considered. In addition to completing the online application, applicants must submit a PDF of their academic transcript from their most recently completed school year (emailed tofoundation@arrl.org).

Applications are due on January 31, 2019, by 11:59 PM ET. *Applications* without accompanying transcripts *will not be considered*. Awards winners are typically notified in mid-May by USPS mail and email.

TWO 40-METER BROADCAST INTRUDERS GONE IARU REGION 1 MONITORING SYSTEM REPORTS

The IARU Region 1 Monitoring System (IARUMS) reports that two long-time broadcast intruders on 40 meters are gone. IARUMS Coordinator Wolf Hadel, DK2OM, said in the August IARUMS <u>newsletter</u> that Radio Hargeisa in the Republic of Somaliland on 7.120 MHz, and Radio Ethiopia on 7.140 MHz, departed the band during the last week of August. "We did not miss them," he commented.

IARUMS did report increasing military traffic on 7 and 14 MHz, "especially on digital modes from Russia and China." In addition, a wideband over-the-horizon (OTH) radar in China has caused serious problems on 20 meters, while an Iranian radar on 28.860 MHz "could be heard under sporadic E conditions." German telecommunications authorities have filed a formal complaint.

Hadel said a Russian Navy system believed to be in Moscow appeared on 7.182 MHz on F1A, a 200 Hz shift, identifying as RDL. German telecommunications authorities were notified.

Hadel also reported "childish behavior" by hams in western and eastern Ukraine "insulting each other or playing music every day" on 7.055 MHz (LSB). Reports of amateur band intruders can be submitted via the IARU Region 1 Monitoring System Logger.

DUCIE ISLAND VP6D DXPEDITION< OTHER PACIFIC OPERATIONS ON TARGET

The VP6D Ducie Island DXpedition is set to get under way October 20 and continue until November 3. According to Jacky Calvo, ZL3CW, the equipment, already en route, has been <u>loaded</u> aboard the M/VBraveheart in New Zealand. The Braveheart sets sail for Tahiti in late September, and the team of operators will catch up with the gear in Tahiti to begin their voyage to Ducie Island.

Elsewhere, from September 29 until October 6, Martin Wennergren, A65DC, and friends will operate from Christmas Island as VK9XT. They plan to be on 160 through 10 meters, excluding 60 meters, kicking things off with the CQ World Wide RTTY Contest for the first 48 hours, with SSB and CW on non-contest bands, then CW, SSB, and RTTY on HF, using FT8 "only when no other operation is happening or on bands that are opening or closing," they've said. VK9XT logs will go to LoTW and Club Log.

Stan Vatev, LZ1GC, is heading to Samoa and will be on the air by September 28 as 5W0GC. He'll meet other operators for the YJ0GC operation from Vanuatu, set to begin on October 15. Logs will be uploaded to LoTW. HF operation will concentrate on 160 and 80 meters. <u>More details</u> are on the 5W0GC/YJ0GC website.

WEDNESDAY NIGHT NETS

Additional Net Controls are needed for the Wednesday Night ARES, RACES & DLARC net. If we have enough interested operators, it will only be necessary for each operator to have only one net session in each three month period. Actually 13 weeks in a period, so 13 net controls would be ideal, and maybe some extras to fill in if needed. This would give us a pool of experienced controls, for any emergency which would arise. Interested operators should contact Don / KC3II at kc3ii@arrI.net. The NIMS IS-700 and ICS-100 courses are not required to be a net control, but should the need arise and we do supply controls and operators for real emergencies, then the courses requirement will be in effect and EMA issued IDs will be needed to be on the scene of an emergen

RACES EMERGENCY REQUIREMENTS

As of September 2006, NIMS IS-700 and ICS-100 course certifications are required in order t receive the county issued photo IDs. The photo IDs are required by federal law for participation in, on site RACES emergency operations. These courses can be taken on line by going to www.fema.gov and following the directions. These requirements are not needed to participate in the weekly Wednesday nets. The only requirement for these nets is a valid amateur radio license and an interest in emergency communications.

FLOTSAM AND JETSAM

Arguably the worst sea disaster in history was the torpedoing and destruction of the German ship Wilhelm Gustavo by a Russian submarine in the Baltic Sea in January 1945. The ship had no military value and the outcome of the war was, by then, a foregone conclusion. Nevertheless, 9,343 (mostly women and children) were lost trying to escape to western Germany, an area that was expected to be occupied by the Americans and British rather than the Russians.

Shown below, is an actual letter that was sent to a bank by an 82-year-old woman. The bank manager thought it amusing enough to have it published in the New York Times. Dear Sir

I am writing to thank you for bouncing my check with which I endeavored to pay my plumber last month. By my calculations, three nanoseconds must have elapsed between his presenting the check and the arrival in my account of the funds needed to honor it. I refer, of course, to the automatic monthly deposit of my entire pension, an arrangement which, I admit, has been in place for only eight years. You are to be commended for seizing that brief window of opportunity, and also for debiting my account \$30 by way of penalty for the inconvenience caused to your bank.

My thankfulness springs from the manner in which this incident has caused me to rethink my errant financial ways. I noticed that whereas I personally answer your telephone calls and letters, --- when I try to contact you, I am confronted by the impersonal, overcharging, pre-recorded, faceless entity which your bank has become.

From now on, I, like you, choose only to deal with a flesh-and-blood person. My mortgage and loan repayments will therefore and hereafter no longer be automatic, but will arrive at your bank, by check, addressed personally and confidentially to an employee at your bank whom you must nominate. Be aware that it is an OFFENSE under the Postal Act for any other person to open such an envelope.

Please find attached an Application Contact which I require your chosen employee to complete. I am sorry it runs to eight pages, but in order that I know as much about him or her as your bank knows about me, there is no alternative. Please note that all copies of his or her medical history must be countersigned by a Notary Public, and the mandatory details of his/her financial situation (income, debts, assets and liabilities) must be accompanied by documented proof. In due course, at MY convenience, I will issue your employee with a PIN number which he/she must quote in dealings with me. I regret that it cannot be shorter than 28 digits but, again, I have modeled it on the number of button presses required of me to access my account balance on your phone bank service.

As they say, imitation is the sincerest form of flattery. Let me level the playing field even further.

When you call me, press buttons as follows: **IMMEDIATELY AFTER DIALING, PRESS THE STAR BUTTON FOR ENGLISH** #1. To make an appointment to see me.

- #2. To query a missing payment.

CONICAL WINDOM ANTENNA N. Tyutin, UA4QA,

The antenna was installed and tested by UA4QA. Despite of the antenna was installed at a small height between the roofs of a two houses, on the 20 meters the antenna did + 2 + 4 balls (at S-Scale) compare to usual one- wire Windom designed for the band. **Figure 1** shows the design of the antenna.

Antenna made of seven lengths in 0.477- lambda and 3-mm diameter each. The wires were going through two ebonite rings and soldered in the places of the insulators and the connection of the one- wire feeder. (*Note by I.G.: There is no information about placement the rings on the antenna*).

Feeder should be athwart to the Antenna for the distance at least 2/3 lambda and then should not have sharp bending.
