#### Some New Rules Going into Effect this Year for ARRL Field Day

After taking a few detours over the past couple of years due to the COVID-19 pandemic, **ARRL Field Day** rules are being updated on a permanent basis starting this summer. ARRL conducted a Field Day community survey with invitations propagated far and wide, and direct emails sent to more than 15,000 individuals and ARRL-affiliated clubs. After sorting through, reviewing, and discussing the survey results, the ARRL Programs and Services Committee recommended a number of rule changes for ARRL Field Day, which will take place this year over the June 25 – 26 weekend. Starting this year, the maximum PEP output for a transmitter used by anyone submitting a Field Day log will be 100 W. The power multiplier of 2 will remain in place, and the high-power category will be removed from the rules. Until this year, the maximum low-power limit had been 150 W for most ARRL-sponsored operating events. The power multiplier will remain at 5 for QRP participants running a maximum of 5 W or less. As previously announced, 100 W is now the low-power category limit for all ARRL and IARU HF Contests, effective January 1, 2022.

A couple of changes instituted initially as accommodations for the COVID-19 pandemic will remain. Class D (Home) stations will continue to be able to earn points for contacts with other Class D stations. The club aggregate scoring change initiated in 2020 as a temporary measure will become part of the permanent rules. In the aggregate scoring plan, the scores of individual stations are combined under the score of a single club.

Another change, involving Rule 7.3.2 Media Publicity, has been modified. Rules to date have offered 100 bonus points for attempting to obtain publicity and demonstrating same. With the ease of posting via Facebook, Twitter, Instagram, and various other media websites, Field Day participants will now be required to obtain publicity, not just try to do so. Any combination of bona fide media hits would qualify for the bonus points. For example, posting the details of your upcoming or ongoing Field Day activity, or your Field Day results, on a club or news media site, on Facebook, or via Twitter and Instagram would meet the bonus criteria. Photos and videos are encouraged as part of media posts.

#### WEDNESDAY NIGHT NETS

Additional Net Controls are needed for the Wednesday Night ARES, RACES & DLARC net. This would give us a pool of experienced controls, for any emergency which would arise. The NIMS IS-700 and ICS-100 courses are not required to be a net control, but should the need arise, and we do supply controls and operators for real emergencies, then the courses requirement will be in effect and EMA issued IDs will be needed to be on the scene of an emergency.

All Radio Amateurs are welcome to participate in the ARES, RACES and DLARC net. This net meets Wednesday at 1900 hours local time, on the W3OK Repeater 51.76, 146.70 and 444.90 (pl 151.4). With an alternate frequency of 147.350 (DCS 315) W3OI Repeater. QCWA Chapter 17 holds a net Monday evening at 8:30 PM on 3960 +/- depending on conditions. Other inputs are the 146.85 repeater, (151.4 PL) and Echolink at K2PM-R. Mid-Atlantic D-Star Net meets each Tuesday at 7:30 PM. The following repeaters Dstar repeaters are available in the Lehigh Valley. W3OK -145.11000MHz -0.600 Port C - W3OI -147.16500MHz +0.600 Port C, - W3OI - 445.02500MHz -5.000 Port B All repeaters on the net are linked through Reflector 020 port A, so all stations checking into the net should make sure that they have their local repeater call sign followed by the letter "G" in the eight positions of the RPT2 field. Otherwise, you will only be heard locally and not over the Reflector. Dongle users wishing to check into the net should Log On by connecting directly to Reflector 20, port A, rather than through your local repeater to conserve local bandwidth.

#### A Contesting Word to the Wise

When submitting contest logs, many contest sponsors will provide an email confirmation of your entry. It's always advisable to check your confirmation email or the contest's Logs Received page to ensure that your entry has been submitted and that your entry category, club name, and location are correct. ARRL, CQ, and other contest sponsors allow you to resubmit your log with any corrections before the log submission deadline. The most recent uploaded log will be used for scoring purposes. After the deadline, some contest sponsors will release raw scores that reflect the results before any log checking has been completed. If, after the deadline, you notice an error in your log submission, contact the contest sponsor to correct it before the results are tabulated and made public. -- The ARRL Contest Update
