#### Back on the road again.

It has been less than a month since the ARRL Headquarters trip and the DLARC folks are on the road again. This time it was to the Battleship New Jersey. Al W3CE arranged the trip through the club that operates a station in the radio room of the battleship.

As with the trip to ARRL, we began on the Monday morning with a quick breakfast at the diner. After breakfast, the six of us piled in to Al's van for the trip to Camden. The trip down was uneventful, a nice surprise given that it was during the morning rush hour.

Arriving in Camden, we found easy parking in the parking garage adjacent to the Battleship. There is a short shuttle bus ride to the pier (which is good because you can do enough walking on the ship). We met with our guide and escort at 10am. We decided to split up the group into two to make operating in the radio room a little less crowded (if you've been to the milk-house on a Wednesday night you'd understand why). Al and I headed to the radio room and the others (Dave NB3R, Barry KU3X, Gary N2AUO, & Mike KB3LOD) headed on a guided tour of the ship.

The radio room is remarkably restored to its form of the early nineties. The actual amateur radio operating positions are a mix of military type and commercial ham gear. There are no beam antennas on the ship. There is a discone antenna near the bow and another multi-band antenna mid-ship, plus some wire antennas. As you can imagine, getting a good ground is not a problem.

Al settled in on 40M and I took 20M. It took a while longer than at ARRL, but I eventually had a pile-up of stations trying to work the New Jersey. It was nice to work some hams that remembered her from their days in the service. One fellow, in particular, remembered her 16-inch shells screeching overhead during his time in Vietnam.

The group that was touring while Al and I were operating met us around noon in the radio room. All of us then headed to the mess for lunch. After lunch, the others headed to the radio room for some time operating and Al and I headed off on a quided tour of the ship.

We finished up around 4:30 and headed back to the Lehigh Valley. The return trip was a bit slower than the trip down (once again in rush hour). We ended the day with a group dinner back here in the valley.

Everyone agreed that it was a great trip. We are now trying to come up with some ideas for addition trips. If you have any ideas, please be sure to let us know.

Speaking of events, Field day is rapidly approaching. Be sure to join us at Louise Moore Park on the weekend of June 25-26. We will be setting up at 9AM on Saturday and will begin operating about 2PM. We will begin tear-down at 2PM on Sunday.

Antenna Ordinances, You and the ARRL

On Wednesday, April 27 at 9 PM (EDT), the ARRL Atlantic and the West Gulf Divisions will present Antenna Ordinances, You and the ARRL.

Speakers for this presentation will be Director David Woolweaver, K5RAV; ARRL General Counsel Chris Imlay, W3KD, and noted antenna zoning lawyer Fred Hopengarten, K1VR.

The scope of the webinar will be an overview of common local antenna regulations that can impact Amateur Radio tower installations, as well as how the local amateurs should approach dealing with local officials. Following the presentations by Imlay and Hopengarten, participants will have the opportunity to ask general questions related to the topic.

While useful information will be shared, the presenters will not be answering legal questions directly geared towards resolving any specific antenna zoning situation. They will not have the full facts of the situation and may not be licensed to practice in your state. Regulatory Information Manager Dan Henderson, N1ND, will be happy to provide you with information and contacts for your specific situation.

#### FCC SEEKS TO RAISE THE FEE FOR VANITY CALL SIGNS

The FCC released a *Notice of Proposed Rulemaking* (*NPRM*) on May 3, seeking to raise the fee for Amateur Radio vanity call signs. Currently, a vanity call sign costs \$13.30 and is good for 10 years; the new fee, if the FCC plan goes through, will go up to \$14.20 for 10 years, an increase of 90 cents. The FCC is authorized by the *Communications Act of 1934 (as amended)* to collect vanity call sign fees to recover the costs associated with that program. The vanity call sign regulatory fee is payable not only when applying for a new vanity call sign, but also upon renewing a vanity call sign for a new term. Instructions on **how to comment** on this *NPRM* are available on the FCC Web site.

The vanity call sign fee has fluctuated over the 14 years of the current program -- from a low of \$11.70 in 2007 to a high of \$70 (as first proposed in the FCC's 1994 *Report and Order*). In 2007, the Commission lowered the fee from \$20.80 to \$11.70. The FCC said it anticipates some 14,600 Amateur Radio vanity call sign "payment units" or applications during the next fiscal year, collecting \$207,320 in fees from the program.

#### Vanity Fee Due for New, Renewal Applications

The vanity call sign regulatory fee is payable not only when applying for a new vanity call sign, but also upon renewing a vanity call sign for a new term. The first vanity call sign licenses issued under the current Amateur Radio vanity call sign program that began in 1996 came up for renewal five years ago.

Those holding vanity call signs issued prior to 1996 are exempt from having to pay the vanity call sign regulatory fee at renewal, however. That's because Congress did not authorize the FCC to collect regulatory fees until 1993. Such "heritage" vanity call sign holders do not appear as vanity licensees in the FCC Amateur Radio database.

Amateur Radio licensees may file for renewal only within 90 days of their license expiration date. All radio amateurs must have an FCC Registration Number (FRN) before filing any application with the Commission. Applicants can obtain an FRN by going to the <u>ULS</u> and clicking on the "New Users Register" link. You must supply your Social Security Number to obtain an FRN.

#### ARRL Processes License Renewals, Including Vanities

The ARRL VEC will process license renewals for vanity call sign holders for a modest fee. The service is available to ARRL members and nonmembers, although League members pay less. Routine, non-vanity renewals continue to be free for ARRL members. Trustees of club stations with vanity call signs may renew either via the ULS or through a Club Station Call Sign Administrator, such as ARRL VEC.

The ARRL VEC will handle vanity license renewals for ARRL members for a small fee (license renewals for members with non-vanity call signs are free). Visit the Call Sign Renewals or Changes web page for complete instructions on how to have the ARRL renew your license for you or for how to do it yourself. License application and renewal information and links to the required forms are available on the ARRL Amateur Radio License Renewal web page. The <a href="FCC's forms page">FCC's forms page</a> also offers the required forms.
